4. Matters Arising

Action Point 1 from January Meeting re DfT Consultation on ACC Guidance

Members were reminded that DfT had consulted all Airport Consultative Committees on their practices and procedures to assess the need for a review of the current Guidance for ACCs issued in 2014. The intention being not to simply jump into revision of the Guidance but to consider the need for a review and possible revision. A task and finish

group comprising the Chair, Vice Chair and Secretary completed the questionnaire which was submitted before the deadline of 18th February.

5. Chief Executive's Report

The CEO (IF) updated the committee on the progress the airport was making and highlighted the following:

Recent cargo/freight and passenger traffic;

Masterplanning for the development of GPA to include Spaceport

Spaceport project and the airport continues to work closely with the council, project team and the launch service provider Astraeus. A consultation event on a proposal to submit a planning application was held on the 23rd February 2022. The event attracted some 100 attendees. A second event is to be held in May which will focus on how it relates to STEM and potential jobs.

6. AOCB

The issue of Drones was discussed. It was agreed that this was a problem which the Airport takes very seriously. It was agreed that it might be helpful to ensure the Police and Fiscal service are fully appraised of the problem.
